Before you begin

You need the following:

- A Connector installed in a cloud provider or on your premises, with network connectivity to the E-Series system.

- The domain name or IP address of the storage system controller.
- Admin credentials for the system.

Steps

1. From the BlueXP navigation menu, select **Storage > Canvas**.
2. From the Canvas, select **Add Working Environment** and select **On-Premises**.
3. Next to **E-Series**, select **Discover**.
4. If you're prompted, create a Connector.

5. On the *E-Series Cluster Details* page, enter the domain name or IP address of the storage system controller, admin credentials for the system, and then select **Add**.
