BlueXP ransomware protection role-based access control privileges

BlueXP ransomware protection uses role-based access control (RBAC) to govern the access that each user has to specific features and actions. The service uses the core BlueXP roles of Account Admin and Viewer (non-Account Admin).

The following table indicates which actions that each role can perform.
