## View and update OAuth 2.0 status

### Overview

This API is used to enable and disable OAuth 2.0 in the cluster. The PATCH request enables and disables OAuth 2.0 in the cluster.

### Examples

#### Retrieving the OAuth 2.0 status in the cluster

The following output shows the OAuth 2.0 status of the cluster.

```
# The API:  
/api/security/authentication/cluster/oauth2  
  
# The call:  
curl -X GET "https://<mgmt-ip>/api/security/authentication/cluster/oauth2"  
-H "accept: application/hal+json"  
  
# The response:

}
```

#### Enabling the OAuth 2.0 in the cluster

The following output shows how to enable the OAuth 2.0 in the cluster.

application/hal+json" -d '{ "enabled": true }'
```
