## What's new in SnapCenter software 6.2

The 6.2 release of SnapCenter software includes the following new feature.

<a href="#">Support for ASA r2 systems</a>	<p>SnapCenter 6.2 (server and plug-ins) along with ONTAP 9.17.1 supports both primary and secondary protection of applications running on physical systems (Linux and Windows) and Virtual Machine File Systems (VMFS) utilizing hierarchical consistency groups.</p> <p>After you upgrade to SnapCenter 6.2 and ONTAP 9.17.1, SnapCenter changes flat consistency groups to hierarchical consistency groups during the first scheduled backup.</p>

The NetApp Console, built on the enhanced and restructured BlueXP foundation, provides centralized management of NetApp storage and NetApp Data Services across on-premises and cloud environments at enterprise grade—delivering real-time insights, faster workflows, and simplified administration, that is highly secure and compliant.
